Singapore Artist Stefanie Hauger Wins

UOB Southeast Asian Painting of the Year Award

**Singapore, 26 November 2013** – United Overseas Bank (UOB) has awarded the UOB Southeast Asian Painting of the Year award to Singapore artist Ms Stefanie Hauger for her abstract piece of a healthy planet as seen from space. Titled *Space Odyssey*, the painting was chosen from among the national winners of the UOB Painting of the Year competition winners held in Indonesia, Malaysia, Singapore and Thailand.

A renowned panel of artists, established curators and influential art critics from around Southeast Asia chose Ms Hauger's piece based on its unconventional technique and timely message. Ms Hauger created the piece by pouring paint onto the canvas in layers. She then manipulated the paint in the image of a *mandala*, the concentric circular diagrams used to help one focus during meditation. It is by meditating on a healthy planet that Ms Hauger hopes to instil in the audience a desire to care for the planet and to repair the damage being done to it.

Ms Hauger's piece was also announced the winner of the 2013 Painting of the Year (Singapore) competition.

On winning the awards Ms Hauger said, "Winning such a prestigious award as the UOB Southeast Asian Painting of the Year is an affirmation that I made the right decision to become a full-time artist, one of the most fulfilling professions there is but which is not without risk. An artist pursues their passion for the love of the craft and the freedom to express their innermost soul. To be recognised and supported by UOB in this is the ultimate inspiration to continue."

Mr Wee Ee Cheong, Deputy Chairman and Chief Executive Officer, UOB Group, said, "We see art as a common language that can connect people across cultures and generations. It can inspire innovation lift the human spirit and has an important role in strengthening a community.

UOB also announced 17-year-old Mr Lim Quan Zhao as the winner of the 2013 UOB Most Promising Artist of the Year, Singapore, award for his piece titled *The Transcendence of Love*. Inspired by a latenight journey home, Mr Lim captured the quiet beauty of a father caressing his young son's head on a

public train.

Judges of the Singapore competition were Mr Chua Soo Bin, gallery owner and Singapore Cultural Medallion recipient, Mr Mok Kim Chuan, Head of Sotheby's Southeast Asian Paintings department and

Dr Susie Lingham, Director of the Singapore Art Museum.

The UOB Southeast Asian Painting of the Year award was judged by the Singapore panel of judges together with Ms Lim Wei-Ling, the founder of the two leading art galleries in Malaysia, Professor Preecha Thaothong from the Thai Art Department, Silpakorn University, Thailand and Mr Amir Sidharta,

the Director of Sidharta Auctioneer in Indonesia.

The awards ceremony was held at the 72-13 Gallery. Guest of Honour, Acting Minister for Culture Community and Youth and Senior Minister of State, Ministry of Communications and Information,

Mr Lawrence Wong, together with Mr Wee, presented the awards.
