

Terms and Conditions Governing UOBSend Pricing Discount Promotion for BizTransact and BizGlobal

1. The UOBSend Pricing Discount Promotion ("promotion) is available from 10 March 2025 to 31 March 2026 ("Promotion Period") to customers who have either a BizTransact account or BizGlobal account with United Overseas Bank Limited ("UOB" or the "Bank"). UOB reserves the right to amend the Promotion Period in its sole and absolute discretion. By using the UOBSend service, you agree to be bound by these terms and conditions.

2. Participation and Eligibility

- 2.1. To be eligible for the Promotion, you must be an existing customer of the Bank, and:
- 2.1.1. You have at least one valid and active BizTransact account and/or BizGlobal account (the "Account(s)");
- 2.1.2. The Account(s) must be validly existing (i.e. must not be suspended, cancelled or terminated), in good standing, and conducted in a proper and satisfactory manner at all times, as determined by the Bank in its sole and absolute discretion; and
- 2.1.3. You are an existing user of or have signed up for UOB Infinity (UOB Business Internet Banking Service).
